Awards Criteria – Mary Lee Walter and Susan Lenihan

The following is the wording that appeared on the application form to replace the previous wording that had said applicants could not reapply the following year with the same idea.

The FCC is entering into a pilot program: An application for a second year of funding may be considered if the applicant is gathering data to support the application for future non-FCC funding. Any application for a second year of funding is subject to the FCC voting and selection process.

If the grant is awarded in 2022, and the awardee wants to apply again for 2023, he/she must reapply and would be subject to the same process as before. If they are again granted the award in 2023, they will be encouraged to get assistance in finding outside funding by talking with Marcia Quint.

Membership Recruitment Steps for Moving Forward: Maggie Fowler

Several items were discussed that might be points to consider as we move toward our 2023 membership goal.

- Need to recognize membership contributions by recognizing five-year breakdowns so that current members can publicly advance from one level to the next.
- Publicize the amount of money FCC has donated to each department.
- Publicize how FCC funding might have affected individual students.
- Add a younger women's group.
- Work on membership diversity.
- How can we better publicize what we do?
- In-person gatherings are very important, but we do not want to lose our out-of-towners while focusing on in-person events.
- Work on our Valentine's Day Reach-Out.
- Grow our committees in order to get more members involved.

 - On October 18, 2021, the Awards Committee reviewed the documents used for award applications. We revised the part about allowing an applicant to apply for a second

- Current Membership: 78 members. This reflects new members Andrea Thomas and Marsha Benney and dropped members Tina Saunders and Carolyn Berra. Although we reached out to both Tina and Carolyn last month, they finalized their drop this month.
- All Souls Day: FCC members joined the zoomed CSJ Motherhouse November 2nd *All Souls Mass*, during which FCC Member Sr. Donna Gunn presented an excellent reflection. It was a beautiful reminder of FCC's role in carrying out the CSJ charism to serve the dear neighbor.
- November 18th Reconnect: Although this is an Alumni event, the Committee is proud that FCC is both sponsoring the event and that JoAnn will welcome attendees. We look forward to reconnecting with fellow classmates.
- Sponsorship Update: Joan Kelly reports that to date we have \$9,295 left from the TOTAL scholarship fund that is currently not committed to anyone. Let Joan know if you have a prospect who might benefit from this opportunity to join FCC.
- Recruitment Survey: Wendi is working on a tool to help members in their recruitment considerations and to help the Membership Committee assess how engaged FCC members are in our Recruitment Campaign.
- The Committee discussed both the opportunity and need for a Diversity Recruitment Strategy as part of FCC's Recruitment Campaign. Alice Bell has agreed to help and will contact new member Andrea Thomas to join her in this venture. Alice's email reflects FCC's imperative to better represent Fontbonne's diverse environment.
